collaboration. Question: would a new applicant who works with a former awardee still be eligible for the PP? Should the PP apply only to the PI or to the entire team?

 - ILO 1a revision recommendation

<u>Current Wording</u>: Describe how knowledge is discovered in various fields of study. Aaron explained how the feedback they got affected this wording and why they propose the revisions (Blooms Taxonomy)

<u>Proposed Revisions</u>: (a) Evaluate how knowledge is discovered in a field of study, or (b) Evaluate how knowledge is discovered or created. The second option carried unanimously. Explain vs. evaluate. Kim said if a graduating student could explain how knowledge is obtained, she would count that a win. On the other hand, she would expect a graduate student to be able to evaluate the question.

- Review and discussion of detailed statements for ILOs 1 and 2. Kim asked everyone to pair up (Academic Affairs with Student Services) and reflect. Renee asked if there is a process in place for revisions going forward? Kim said there isn't, but we should put that in place.
