#### Unfinished Business

- **Permanent S/U Grading Policy** - *on hold; awaiting feedback from UGC*

  - Discussion of changing wording to indicate “Academic Unit Leaders” instead of Chairs/Directors.

#### New Business

- **4-day class schedule**

- Proposal overview given by Levin and Jeri Lyons.

DISCUSSION:

- Let's not rule out Friday as the non-teaching day because of a fear that faculty won't be engaged on Fridays.
- Do we want to make a plan that won't work in the future if our enrollment grows? Can we avoid that?
- How many of our students come to campus 5 days each week? Would this really reduce their number of days on campus?
- Students and faculty prefer 2-day classes now. Making all courses 2-days each week would match preferences
- If we go to this schedule it needs to be campus-wide. Can we make any exceptions? Some programs, like nursing, can't make this schedule work as currently envisioned.
  - Nursing would want an exception but could work with the new schedule. Is it okay for a few groups to have exceptions? Probably. We don't need 100% of all classes on this schedule.
- What would this do to space use across campus? Do we have the space we need? That would have to be assessed.
- Will section caps need to be raised?
- How can we schedule this to maintain course selection options for students? We might need an outside audit from professionals to look at the time and space issues.
- Would this pressure faculty to take on more service, if we had an "open" day for it?
- Even a half day with no classes creates a better schedule and campus community. At other institutions the full or half-day teaching moratorium works very well.
- How do we assess the feasibility of this? There was a space audit 11 years ago that was comprehensive and expensive and then never used. How do we approach this?
  - Space first: can we even fit these classes in our space?
  - If space is available, can we give students the schedule options that they need?
  - Can we mitigate space/time concerns by putting more online?
  - Can we make schedules more flexible by adding hybrid classes with components that don't meet face to face?
- There are clear pedagogical benefits to 75-minute courses
- Couch: from the administrative systems side, this would take at least 2 years to implement. This means starting in Fall 2024 at the earliest.
- What are the main goals of this policy? What do we prioritize? Universal professional development time? Student schedules with 1 open day? Faculty schedules with 1 open day? Better pedagogy via 75-minute classes? How much should we compromise on different aspects of the proposal?
- To do: We need to think about what big questions we need to answer before moving forward with discussion.
