**PLUS AUTHORIZATION FORM 2009-2010**

- Each PLUS loan is in one parent's name and that parent must be the one to complete the credit check and promissory note.
- Student/parent must have completed a FAFSA to be awarded a PLUS loan. We will process the loan for the amount accepted, plus the lender's loan origination fee of 3%.
- If you have never borrowed a PLUS before for this student, you will need to sign a promissory note with the lender. If you have borrowed a PLUS in the past for this student, with the lender chosen below, you will not be required to sign a new note.
- If you select one of the lenders below, the loan funds will come via electronic fund transfer (EFT) and be posted to your student's UNC bill. If no lender is designated, we will be unable to process this loan.
- If you choose a lender that is not on the list below, PLUS funds can come either by EFT or by check. If you receive a check, you must endorse it and return it to UNC for payment to your student's account.

If your student's UNC bill is paid in full by the PLUS loan, any refund generated from the PLUS loan can either be sent to you or given to your student. Your authorization below indicates how you want the remaining funds to be disbursed. If the PLUS loan comes in first and all of it is used to pay the student's bill, any refund that is generated from the student's subsequent aid will go to the student.
