2018 A.M. AND JO WINCHESTER DISTINGUISHED SCHOLAR ANNOUNCEMENT

Dr. Deanna Meinke, Professor of Audiology and Speech-Language Sciences, in the College of Natural and Health Sciences, was awarded the 2018 Winchester Distinguished Scholar by UNC's Faculty Research and Publications Board. The award, which recognizes demonstrated continued excellence in scholarly activity at UNC for at least five years, comes with a \$2000 monetary award and the permanent designation of A.M. and Jo Winchester Distinguished Professor.

Authority to Submit Proposals & Accept Awards

Signature authority is very limited at UNC. Only a handful of individuals on campus have been delegated the legitimate authority to represent and/or bind UNC in proposal submissions and agreement negotiations. Please consult with OSP before submitting or signing any proposal or award documents, to ensure you are not putting yourself or the institution at risk.

PROPOSAL PREPARATION TIMELINE

Faculty, staff, and students are reminded to complete and submit OSP's internal Notice of Intent as soon as possible when considering an application to external funding agencies. This initial step allows unit and college leaders, as well as OSP staff and Office of Research leadership to be aware of upcoming proposals in the pipeline, and is the starting point for OSP's support of your proposal development and submission. Further, it is policy to have all final proposal documents and approvals submitted to OSP three working days before the funding agency's deadline. This buffer time between internal deadline and sponsor deadline is critical to ensure applicable compliance requirements are met and to mitigate against the myriad of issues that can arise when proposal submission is delayed to the last minute (e.g.: bug in agency system; internet failure; file corruption; etc.).

NSF Faculty Early Career Development Program (CAREER)

National Science Foundation's CAREER Program is a Foundation-wide activity that offers NSF's most prestigious awards in support of early-career faculty who have the potential to serve as academic role models in research and education and to lead advances in the mission of their department or organization. Successful Principal Investigators will propose creative, effective research and education plans, developed within the context of the mission, goals, and resources of their organizations, while building a firm foundation for a lifetime of contributions to research, education, and their integration. Proposers must meet all of the following eligibility requirements:

- Hold a doctoral degree in a field supported by NSF by the cognizant Directorate's deadline for submission of CAREER proposals;
- Be engaged in research in an area of science, engineering, or education supported by NSF;
- Be employed in a tenure-track (or tenure-track-equivalent) position as an assistant professor (or equivalent title) as of October 1 after the proposal submission;
- Be untenured as of October 1 following the proposal submission; and
- Have not previously received a CAREER award. (Prior or concurrent Federal support for other types of awards for non-duplicative research does not preclude eligibility.)

Interested faculty are encouraged to submit a Notice of Intent to OSP as soon as possible. NSF's deadlines for 2018 CAREER proposals deadlines are July 18, 19, and 20, depending on the directorate to which the proposal is being submitted
