### **TRAVEL STUDY AGREEMENT FOR TRAVELLERS**

#### **Egypt 2012**

I commit to participate in the upcoming travel study program in 2012 to be organized by ARAMFO Inc., a Colorado corporation ("ARAMFO").

#### **Payment schedule:**

\$500 first payment due: December 1, 2011

\$500 second payment due: January 20, 2012

\$500 third payment due: March 15, 2012

\$1800 paid by a check that will be dated May 21st, and cashed by ARAMFO at this time.

I understand that the fee for this trip is \$3,300. I understand that the \$3,300 will cover my international flight, domestic transportation in Egypt, meals, hotels, and the university visits. Other incidental expenses will be your responsibility.

I understand the cancellation policy, explained below.

#### **Cancellation Policy:**

All cancellations must be received in writing. The following cancellation schedule applies:

**Cancellations made before March 15, 2012 will receive the full payment minus \$100 administrative fees.**

**Cancellations made between March 15, 2012 and April 15, 2012 will receive the full payment minus \$750.**

**Cancellations made between April 16, 2012 and May 1, 2012 will receive \$100, out of the \$1500 paid.**

**Cancellations made ON OR AFTER May 1, 2012: NO MONEY WILL BE REFUNDED.**

#### **Important Requirements:**

I am in good physical and mental health. I commit to discuss any health problems with the trip organizers at ARAMFO before the trip.

I commit to have all of the required immunizations and vaccinations recommended by the Centers for Disease Control for travel to Egypt (see cdc.gov website).

I understand that I am not covered for any medical, accident, or life insurance through ARAMFO, the University of Northern Colorado, (or any officers, directors, agents, subsidiaries, joint ventures, teachers and employees of ARAMFO (collectively, the "Related Parties"). . I will be responsible for all costs relating to any medical issue or accident.

I agree to respect the culture of the country I will visit and to respect all verbal and written instructions provided by ARAMFO, the University of Northern Colorado, or any Related Parties.

I agree that neither ARAMFO, the University of Northern Colorado, nor or any Related Parties shall be liable to me for any failure or delay caused by events beyond their control, including, but without limitation, my failure to furnish necessary information; sabotage; failure or delays in transportation or communication; acts of war, failures or substitutions of equipment; disputes; accidents; or other failures.

I agree that this Agreement shall be governed and construed in accordance with the laws of the State of Colorado as they apply to a contract executed, delivered, and performed solely in such State. The parties hereto agree that all actions or proceedings arising in connection with this Agreement shall be tried and litigated exclusively in the State courts located in the County of Denver, State of Colorado. The aforementioned choice of venue is intended by the parties to be mandatory and not permissive in nature, thereby precluding the possibility of litigation between the parties with respect to or arising out of this Agreement in any jurisdiction other than that specified in this paragraph. No such actions or proceedings shall be brought against ARAMFO, the University of Northern Colorado, or any Related Parties more than six months after the completion of this trip.

This Agreement constitutes the entire agreement of the parties and supersedes all prior representations, proposals, discussions, and communications, whether oral or in writing. This Agreement may be modified only in writing and shall be enforceable in accordance with its terms when signed by the party sought to be bound.

The services and products provided or caused to be provided by ARAMFO are provided "as is" without warranty of any kind. in no event shall ARAMFO, the University of Northern Colorado, or any related parties be liable for any direct, indirect, punitive, incidental, special, or consequential damages arising out of, or in any way connected with, the information, services or products provided by it or their suppliers whether based on a theory of negligence, contract, tort, strict liability, or otherwise.

You understand the inherent dangers and difficulties of international travel and you agree to, insofar as legally permissible, to waive all of your rights against ARAMFO, the University of Northern Colorado, or any related parties and agree not to sue or bring any action against ARAMFO, the University of Northern Colorado, or the related parties in connection with this agreement.

Regardless of the prior statements, if ARAMFO, the University of Northern Colorado, or any Related Party is found to be liable, their liability to you or to any third party is limited to \$50.

You will indemnify and hold ARAMFO, the University of Northern Colorado, and any Related Party harmless from any claim or demand, including reasonable attorneys' fees, due to or arising out of your breach of this Agreement, or your violation of any law or the rights of a third party.

You grant Aramfo permission to use, in any medium, without compensation or notice, your name and photo or likeness and further agree to be profiled and featured by Aramfo, in ARAMFO's sole discretion, in future publications or marketing materials including, but not limited to in websites, blogs, tweets, posts, videos, or any other media, without compensation, except where prohibited by law.
