

## University of Northern Colorado; Tailgate Policy

The University of Northern Colorado tailgating policy is intended to provide everyone with an enjoyable and safe environment while attending the UNC Bears home football games. The Department of Athletics in conjunction with the UNC Police Department hopes that you will enjoy yourself, while respecting the rights of others. These rules are intended to be general guidelines. UNC reserves the right to modify these at anytime for the safety and effective administration of the event.

### Below Are The Rules And Regulations Governing Tailgating For UNC Football Games:

1. A tailgate area consists of three parking spots. You may reserve an area for one game or for the entire season. In order to tailgate prior to a UNC football game, your group must fill out a Permit Application. The Permit Application must be turned into the UNC Athletic Department or faxed by 5:00 P.M. the Thursday before the game.
2. Only one (1) vehicle and trailer will be allowed in each tailgate area. If the vehicle is too large for the designated tailgate area, an additional area will need to be purchased.
  - Northern Colorado Athletics limits each tailgating area to 25 people.
  - UNC Police reserve the right to search all vehicles in the tailgate area in an effort to ensure public safety.
3. Each group is required to have a designated person who will be the group liaison and will be on-site throughout the entire time that their group is tailgating. This person will be required to sign-up the group and accept responsibility for their parties actions, while assisting the UNC staff with issues that may arise.
4. Only gas grills will be allowed in the tailgate lot. You must place something under your grill to catch the grease. Letting the grill drip on the pavement will not be tolerated. Dumping any waste is not allowed and may result in eviction from the site and from future tailgates. Tailgaters are prohibited from drilling or punching holes in parking lots for anchoring of tents or any other purpose.
5. Alcoholic beverages shall mean 3.2% fermented malt beverages. Drinks must be in cans or plastic cups. Kegs and bottles are NOT allowed on the premises. No drinking games are allowed. The group will be held responsible for the serving of beverages to individuals of the appropriate age. It is important to remember that serving alcoholic beverages to minors is against the law and violators are subject to prosecution.
6. All people in the tailgate area who intend to drink alcoholic beverages are required to wear a wristband, distributed free of charge at the Central Tailgate Tent.
7. Selling of anything is prohibited! No Political Jargoning! Promotional distribution of a product will not be permitted unless otherwise stated by a UNC representative. Only UNC Athletics or their designated representatives will be allowed to sell merchandise.
8. Tailgating is restricted to the North end Lot M (East of Nottingham Field)
9. Each group is required and responsible for cleaning up after their party. Failure to do so will result in loss of deposit and possibility suspension from further tailgating privileges.
10. Alcoholic beverages may not be taken from the designated tailgate area!
11. Tailgate times are as followed:
  - Set up for tailgating can start 4 hours prior to game time. Tailgating can start 3 hours prior to game time and will end 15 minutes prior to game time.
  - There is no tailgating during the game and no re-entries from the tailgate area once you leave.
  - Tailgating after the game is complete will be permitted for 90 minutes.

12. A valid credit card # must be given before a tailgate area(s) can be reserved. If damages are incurred in your designated tailgate area(s), your credit card will automatically be charged a \$100 fee for damages.

- If no damages are incurred, \$20 will be charged to your credit card for the tailgating fee. If you wish to pay by cash or check, you may do so; however a credit card # must be given.

- By signing this form, you authorize UNC Athletics to charge your credit card for damages.
