SEM Planning Updates

SEM Goals - FINAL

Goal 4: Foster a shared sense of responsibility for students' success.

Goal 5: Maintain an academic portfolio that reflects our high-quality standards and commitment to career readiness and lifelong learning.

Goal 6: Sustain a distinctive and inclusive identity that reflects UNC's strengths and showcases our value proposition.

Goal 7: Maintain the fiscal vitality of UNC while ensuring attendance is financially manageable.

Admissions Partnership Group (A.P.G.)

APG is a cross-functional workgroup comprised of campus representatives with touch points throughout the admissions process including college recruitment contacts, Deans and recruitment liaisons, select program directors including Honors, Soar, CHE, Bear Central, alumni relations, etc.

The goal of APG is to improve collaboration, grow knowledge and awareness, and increase campus engagement in recruitment best practices.

Standing agenda items

- Enrollment funnel and admissions updates
- Key dates: Deadlines, Free App Days, Large Visit Days, etc.
- Calls for support and engagement from campus partners

Key Admissions Enhancements

- **Campus Recruitment Toolkit** – an electronic central repository of shared resources to facilitate all campus interactions involving admission activity.
- **APG Portal (Admissions Partnership Slate Portal)** – secure access to real-time information including student queries, requests for admissions support, etc.

Retention & Success Activities

- **HSI steering committee** which includes subcommittees for admissions/recruitment and retention/student success and crossover membership from SEM Steering and Subcommittees.
- **Updates to policies and practices** to expand access and improve the student experience.
 - Examples: Bursar hold threshold increase, adjustment to withdrawal deadline, financial and test preparation assistance for students who need to take the Praxis for teacher licensure.
- **Actively seeking opportunities** to enhance and support the needs and interests of students pursuing unpaid internships or un-paid work-based learning.
 - Example: State Farm Good Neighbor Citizen Grants.
- **Climate and Student Experience studies** to ensure that our retention and success efforts are informed by students' needs and interests.
- **College success committees with a focus on the faculty role in student success.**
 - Example goal from HSS: Integration of Career Readiness competencies in the HSS curriculum so students may understand the variety of career opportunities in their area of study.

- Graduate Enrollment for Fall 2024 to remain level: 720 (same as Fall 2023)
- First-Time, First-Year (FTFY) Retention Rate: 74% (Fall 2023 to Fall 2024)

International and Graduate Student Enhancements

New Initiatives and Staffing

- ❖ Added three new positions to our graduate admissions & recruitment team
 - Associate Director of Graduate Admissions
 - Two Graduate Recruitment Specialists focused on domestic and international graduate student populations for Greeley campus and programs
- ❖ Realigned territory management for undergraduate admissions counselors
 - Two admissions counselor positions now include a focus on international student populations (both those living in the U.S. and internationally)
- ❖ Updated undergraduate admissions processes
 - New confirmation process
 - Revised internal communication and collaboration between the Office of Global Education and admissions teams

UNC Tuition Promise Proposal

What is the UNC Tuition Promise?

- UNC is committed to addressing the college affordability needs of our students through the new UNC Tuition Promise initiative.
- The UNC Tuition Promise initiative is a combination of grants that cover tuition and fees beginning in Fall 2024 to all UNC students who qualify.

UNC Tuition Promise Requirements

1. Student must be a Colorado Resident or eligible ASSET student
2. Student must file FAFSA (or CASFA) on time to be fully eligible
3. Student must apply for and receive COF
4. Student must be enrolled in 12+ credits (cover up to 16 credits)
5. Student must have Satisfactory Academic Progress (SAP)
6. Student must be an Undergraduate working on first bachelor's degree
7. Student must have a total family income below \$65,000
8. Student must have more than \$0 of gross need
