

#### **External Reviewer Agreement**

#### 5. Grant

[Reviewer] agrees that work product produced in the performance of this agreement shall remain the exclusive property of the University of Northern Colorado, and that the reviewer will not transfer, publish, disclose, or otherwise make the work product available to third parties without the express written consent of the University of Northern Colorado.

This Agreement contains the entire understanding of the parties and may not be amended without the specific written consent of both parties.
