DEFERMENT AND CANCELLATION

By performing certain services, which are explained briefly below, you may be eligible for a partial cancellation, which will reduce your loan balance.

I. Teaching Service

To qualify for cancellation benefits in this category, you must be employed as a full-time teacher for a complete academic year or its equivalent.

The borrower is to complete Part I, Sections A, B, and C.

A request for deferment is to be filed at the beginning of each academic or service year of full-time employment.

A request for cancellation is to be filed at the end of each academic or service year of full-time employment.

Job descriptions are required for each request.

The employer or service unit must complete Part II, Section D.

For the purpose of this category, a teacher is defined as being a person who is a professional employee of a school or school system, which is devoted to providing direct classroom teaching or non-teaching positions of educational nature, such as librarian or counselor.

a) If you are performing a teaching service in a public or private nonprofit elementary or secondary school which is determined by the Commissioner to be a school with a high concentration of students from low-income families and which is listed in the Federal Register, you may be eligible to cancel a portion of your loan that came due during each year of service at the following rates:

15% of your total loan amount will be canceled for each of the first two years of your teaching service.

20% of your total loan amount will be canceled for both the third and fourth years of service.

30% of your total loan amount will be canceled for the fifth year of service.

Refunds of payments made prior to the filing of deferments or cancellation forms will not be made unless they were the result of an error by your lending institution.

- b) If you are a special education teacher, you must submit a description of your students' disabilities, their ages, and the percentage of class with disabilities.
- c) If you are performing a teaching service as a full-time staff member of a Head Start program, you may be eligible to cancel 15% of your total loan for each year of service. Up to 100% of your total loan may be canceled for this type of service
- d) If you are teaching full-time in a field of expertise such as mathematics, science, foreign languages, bilingual education, or any other field of expertise where the State Education agency determines that there is a shortage of qualified teachers, you may qualify for cancellation on your loan the same as a).

II. Military Service

If you are a member of the Armed Forces of the United States on sustained full-time active duty, and complete a full year of service in an area of hostilities (an area that qualifies for special pay under Section 310 of Title 37 of the U.S. Code), you may be eligible for partial cancellation of your loan at the rate of 12 1/2% per year. You may cancel up to 50% of your loan for military service.

III. Peace Corps Cancellation for Perkins Loan First-time Borrowers on or after July 1, 1987

You may be entitled to have up to seventy percent of the amount of this loan canceled if you serve:

- a) As a volunteer under the Peace Corps Act **OR**
- b) As a volunteer under the Domestic Volunteer Service Act of 1973.

The loan will be canceled at the following rates:

- a) Fifteen percent of the total principal amount of the loan on the unpaid balance will be canceled for the first and second twelve-month period of volunteer service.
- b) Twenty percent of the total principal amount of the loan on the unpaid balance will be canceled for the third and fourth twelve-month period of volunteer service.
