	 Must hold certification from the Kansas Commission for the Deaf and Hard of Hearing at levels 4 or 5 in interpretation, transliteration, or both, or 	
	 Must have scored an assessment level of 4 or 5 on the Educational Interpreter Performance Assessment (EIPA), version used prior to 2003 and administered through KSDE, or 	
	 Must have scored an overall assessment level of 4 or 5 on the EIPA, administered through the ASK12, National Boys' Town Institute, or 	
	 Must have current National Interpreter Certification (NIC) by the Registry of Interpreters for the Deaf (RID), and 	
	 Must have a contract that reflects the interpreter is paid as a professional,

Developmental Alternatives (Often "Initial" or "Provisional")	For a professional scoring 3.0 or above but less than 4.0 on the EIPA, a 2 year professional development plan waiver may be submitted for approval to KSDE addressing skill deficits identified by the EIPA. The professional development plan must provide a timeline which includes EIPA retesting to demonstrate progress by the end of the 2 year period. The professional development plan may be used once for a 2 year period to access categorical aid at the professional level. (b) Paraeducator Interpreter/Braille Paraeducator Persons who are interpreting for students who are deaf/hard of hearing may be claimed as paraeducators on the Personnel Report if they scored less than a level 4 and do not have an approved EIPA professional development plan on file as outlined above. The paraeducator interpreting for students should show an interpreting (IN) assignment in the Personnel Report. They must be supervised by a qualified professional and must meet staff development requirements for paraeducators. Documentation of a current assessment and score should be kept on file for interpreters claimed as paraeducators and be made available for auditors.
