## Approval of the Agenda

Added Core Initiative and Grade Replacement policies to New Business. No objections, agenda approved.

# Approval of the January 17 2023 meeting minutes

Announcements/Chair's Report (Levin): S/U Grading is policy going to Faculty Senate today.

## Reports from Councils:

Graduate Council (Cieminski): Looking at 799 again today. Working on credit transfer policy, clarifying language, credit eligibility and mental health resources available.

Liberal Arts Council (Muller): First LAC meeting is Weds, 2/7; working on indirect assessment - Year 2 with rereview of courses from Year 1 and continued articulation of direct assessment process.

Professional Education Council (Mahovsky): Curriculum changes have slowed down, now gearing up for authorization. Need to incorporate additional standards in to current courses.

Undergraduate Council (Welsh): First meeting was 1/10. ROTC aerospace minor and military minors endorsed by UGC. Canvas sub-committee to propose minimal use standards has been created, looking at the differences between online vs. on campus.

Student Senate (Darschewski): Establishing new constitution and presenting to Board of Trustees. Will be reevaluating Bylaws.

<u>Special Reports:</u> None. Unfinished Business:

## • 799 Dissertation and 699 Thesis Credits policy – Back from Codification.

- Wesley commented: "Occupational medicine, physical therapy doctoral programs, are good examples of when research is geared toward practice."
- First sentence under Doctoral Dissertation changed to: "All doctoral programs require either a doctoral dissertation or Doctoral Scholarly Project (DSP) pertaining to a significant topic in the candidate's major."
- o Added word "hours" after word "credit" in all instances.
- o Changed "necessary" to "required" in all instances.
- O Discussion of actual content of 799 credit courses, definition of "completed" vs. "work associated with."
- o Changed sentence back to: "Work associated with 799 credits completed prior to candidacy must directly apply to the dissertation."
- o Discussion of requirement post candidacy in content courses: one credit hour meeting program requirements vs. one credit hour 799.
- o Discussion of half-time vs full time (for 799 only).
- o For sentence starting with: "After advancing to doctoral candidacy," added: "and the only courses remaining are 799, if a student takes only dissertation (799) credits in a given semester, a full-time load is defined as a minimum of three credit hours and a half time load is defined as one credit hour."
- Occumittee is agreeable to moving paragraph starting with "Students enrolled in programs requiring a doctoral scholarly project (i.e., AuD., or D.N.P)" to a different area in document.
- Levin will work with graduate school to clarify full-time/part-time load requirements after student advances to candidacy and bring changes back to committee.

## New Business

# • Admissions Policy Changes

- o Reviewed language changes regarding deferral, clarifying language, notated reasons for deferment have been omitted.
- Question about sentence: "The deadline to confirm enrollment and request deferral is the last business day before the first day of classes for the term the student was originally admitted."
- Levin will work with Erika to determine if this is an intended policy change and bring back.

#### CORE Initiative

- o Clarification that UNC "awards but does not offer" associates degrees.
- o Changed "Student eligibility details" to "Minimum criteria include:"
- o Reviewed Eligibility section, changed "the four year institution" to UNC.
- Levin to clean up CORE language in consultation with Matchet and then send to Codification.

## • Grade Replacement Policy

DISCUSSION: Changed sentence: "The course must not be designated repeatable for credit in the current catalog Exceptions only include unless it is a variable title courses-repeated under the same course prefix, number, and title."

o Title vs. sub-title of courses.

MOTION: Approve policy and send to senate (Benedict), seconded (Welsh).

VOTE: Approved by voice vote
