- Curriculum Standards Recommendations (folder with documents)
 - o Certificate description and residency requirements
 - o Drafted new language for the catalog
 - o Current catalog language
 - Legal counsel has stated that the certificate does not need to be awarded if the student does not complete any coursework at UNC.
 - The necessary language is already included in the catalog.
 - Adding a statement such as "Student must be enrolled at UNC to apply for a certificate" could improve clarity.
 - Something to consider is whether paying for continuous enrollment implies active student status.
 - Does enrollment automatically define someone as a student?
 - A glossary defining "student" would be helpful for consistency.
 - Remove the fourth bullet point "A minimum of 6 credit hours must be taken at UNC" and replace it with "Earn a minimum cumulative GPA of 2.00 in certificate courses, whether taken at UNC or transferred to UNC from any institution. Certain certificate programs may have additional requirements (e.g., a UNC cumulative grade point average of at least 3.00)."
 - It was noted that current language includes a GPA requirement, how would that affect transfer students?
 - Language about GPA will be included in new language
 - The 2.0 requirement will not be impacted by transfer credits.
 - What about pass/fail courses brought in?
 - The certificate program language will need revisions for clarity.
 - The use of "program" seems to be confusing and "certificate courses" was suggested.
 - If a 2.0 GPA is required, there may be caveat language needed.
 - If all credits for a certificate are transferred in, the student will not have a GPA at UNC.
 - If a transferred course does not meet the 2.0 GPA requirement, the student would need to retake the course which can create complications.
 - Would it be simpler to implement a system rule to check for a 2.0 GPA in certificate courses?
 - Students must be enrolled to meet residency requirements.
 - Leatherman is opposed to allowing transfer credits in for certificates with no GPA.
 - If we accept full transfer credits, we should accept the GPA from their institution

- CSU does not specify that their GPA must come from CSU courses How would they implement their overall GPA including transfer credits?
 - Couch can reach out to the CSU registrar for clarification.
- Is there an issue with counting the GPA from transfer credits?
- If a GPA requirement is necessary and the registrar can track transferred GPAs, implementation may be possible.
- The committee should consider the meaning and rigor of certificates.
