Colleges include the following units of the University: Arts and Sciences, Business Administration, Education, Health and Human Sciences, Performing and Visual Arts, and the University Libraries. For purposes of this section 2-3-1301, Severance, "Unit" and "College" may be used interchangeably."

- "Arts and Sciences" should be "Humanities and Social Sciences"
- "Business Administration" should be "Monfort College of Business"
- "Education" should be "Education and Behavioral Sciences"
- "Health and Human Sciences" should be "Natural and Health Sciences"
- "Unit" and "College" may be used interchangeably. is a concern
