Chair's Report (Senbet)

Senate Committee Reports

<u>Academic Policies</u> (Levin) – We gave COD a Grade Submission catalogue policy to review Vaughn mentioned that some are turning in grades too early, which creates big picture issues. This may be an HLC issue to explore. Next we will explore the four-day week class schedule.

Codification (Schuttler) – We have an item under Unfinished Business.

<u>Elections</u> (Schuttler) – Sarah Chase said the voting list would be ready today so ballots can be sent out tomorrow. The list has not been sent yet as of 4:00pm. The Provost questioned if we should create a faculty census date.

<u>Faculty Welfare</u> (Endres) – They meet tomorrow, and are discussing how instructors are promoted. Last year faculty was promoted by years in service at any rank. The policy does not specify "at UNC." FESC members asked Welfare to explore professional exempt and adjuncts as well.

<u>Salary Equity</u> (Kyle) – We are working on a multi-year compensation plan and will address adjustment to promotional raises (it has been ten years since it has been evaluated). Currently when someone is promoted, they fall in parity.

Standing Reports

<u>Board of Trustees</u> (Vaughan) – A consulting firm has been selected to evaluate the President. <u>President</u> (Almquist for Feinstein) – Nothing since last meeting. Please attend The State of the University Address on September 14.

Provost (Fleming) –College based open forums will begin this month with HSS.

New Business

 - FSEC chose representatives from the volunteers for the Provost to consider.
 - Only male faculty volunteered and Finance is not represented. Senbit will ask additional faculty members in an attempt to address gender diversity. His findings will be shared with Provost Fleming.

In <u>Article VI The Salary Equity Committee (SEC)</u>, Schuttler will ask Marshall Parks if, in I. 3. b., can "Only those positions identified as Executive, Senior Management, and Director" be replaced with "Only filled positions reported on the CUPA administrative survey"
