- Salary Update
 - Senbet shared a UNC Summary of Aggregate Faculty and Staff Salary chart and 2019AY vs. 2023AY (4-year Snapshot)
 - The discussion included: The full-time (or FTE) positions of both staff and faculty are declining in response to a decline in student FTE; While the aggregate faculty salary is declining, the staff salary is increasing; This created a widening gap between aggregate faculty and staff salary; This faculty and staff salary gap continues to grow; The increase in the exempt staff salary over the last three years explains almost all of the projected budget deficit in 2023AY; If this trend continues, the faculty is worried that this would have a negative impact on the faculty morale and our budget outlook; Some of the vacant staff positions will not be replaced, which would help in reducing the gap; When faculty are replaced, they are done so at a lower salary; Staff is mostly replaced at a higher salary; Possible case for bringing faculty parity to 100%; Explanations of trends; How do we address this exponential growth in staff salary to have a sustainable budget; Communication strategies and outcomes
