## **DISCUSSION:**

- o Have other directors been polled on the changes?
  - Past directors were in favor, but the School of Performing and Visual Arts (PVA). was against it 4 years ago.
  - The School of Performing and Visual Arts. is not in favor of the change.

- o Directors in EBS are in favor of the changes.
- What's the gain from going from admin to faculty?
  - Directors will be treated as faculty. They can accumulate time to sabbatical, and faculty promotion. They will be eligible for faculty services such as the Senate.

**VOTING:** Aye – 4 / Nay - 18 / Abstain – 4 / Motion fails to exclude PVA from chair/direction definition.
