 Colorado Diploma Endorsement for Biliteracy and State/District Seals of Biliteracy:
 Students who have earned the Colorado Diploma Endorsement for Biliteracy or a State/District Seal of Biliteracy will be awarded credit if their language proficiency was determined through one of the following tests: AP, ASLPI, CLEP, or IB. Students may earn credits in ASL, Chinese, French, German, Japanese, or Spanish as described in the ASLIS Department policy on the ASLPI and in the section "Credit by Examination."

Information item from the Registrar's Office: Couch outlined the rationale for the amendment to the Attendance section of the catalog to reflect current practice.

#### Amend Paragraph 5:

Attendance during the first two class sessions is required. The instructor has the option to drop a student from class if he or she does not attend the first two hours during which the class meets, in order to allow other students to enroll. Once notified by the instructor, the Office of the Registrar will drop the student from the respective course(s). will contact the student to confirm non-attendance. The student will be issued a drop by the instructor from the course if prior to the drop deadline for the given term or issued a grade of UW if after the drop deadline for a given course. Not all instructors will exercise this option; therefore, a student should not assume that non-attendance will automatically drop him or her from class.

The Committee agreed that this may be a good item to include in the Syllabi Resource areas on the UNC website. Toewe will present the catalog amendment as an information item at today's Faculty Senate meeting.
