Academic Appeal Procedure Amendments – Task Force Update

Catalog/One-Stop Language - Amendment Proposals from Codification

The Committee reviewed Codification Committee recommendations to the One Stop site language and discussed the writing style for the site and the rationale for hiring a writer. Toewe will report the update to the Faculty Senate as an information item.

The Committee discussed updated language forwarded by Couch and recommended the following additional edits:

- Strike #7. "All examinations are to be two hours and thirty minutes in length" #1 already states the timeframe: "All final examination periods are to be schedule for 150 minutes in length".
- Create a form, RE: #2: "An instructor who considers examination unnecessary, contingent upon approval of the school director/department chair/program chair, may eliminate the final examination in a course. If no final examination is given, instruction continues through the last week of the semester. In such cases, calluses will meet at the times shown on the final examination schedule."

Couch and Welsh will correspond to create a draft form proposal for Committee review.

- Designate a location on the UNC website for syllabi guidelines, standards, and statements. Toewe will correspond with Bentz to determine next steps.
- Couch will forward updates to Toewe for Faculty Senate presentation.
