- Academic Appeal Procedure Amendment Proposals
 - Satriana provided a revised document. Brian Luedloff attended and was crucial in providing first-hand experience to aid in discussion. Currently, the original document is in place. We should see the AAP back in APC soon.

- Honorary Degree Process Senate Action Form #1103
 - Toewe sent the policy to the President and Provost for their input. Andy identified the process could be streamlined, particularly the nomination and review procedures.
 - o Currently, the full Faculty Senate vote in closed meeting. Do we want the Executive committee to handle it instead?
 - o Murry Honorary degrees haven't been a contentious issue in the past. It has been good to have the full Senate working together for this purpose.
 - o Greene It is a good idea to keep the session closed in case it does become a sensitive discussion.
 - o Toewe We'll leave that section as is: full Senate in closed session.

New Business

- Murry GOAL (Go On And Learn) program Although students in this program do not earn degrees, maybe there can be an option for badging/credentialing and participation in commencement for those who fulfill program requirements.
 - o Participation in graduation increases visibility of the GOAL program and furthers the principle of inclusivity.
 - It is recommended that the GOAL director work with APC to bring forward a proposal to Faculty Senate.
 - Couch Additional language will be needed in the catalog, and the Commencement Committee will need to be brought into the conversation.
