 - Five faculty and five students for each depending on level (UG or GR)
 - Clarification of which bodies are making the appointments: Faculty Senate & Student Senate (UG) or Graduate Council & Graduate Student Association (GR)
 - Language of appointment for the Chair "and a Chair who shall be appointed by the Chief Academic Officer/Provost (CAO) and confirmed by and confirmed by majority vote of each of the Faculty Senate and Student Senate."
 - o 2-1-204(4)(b) Strikethrough section detailing Hearing Panel composition with three of five faculty/students.
 - Quorum will be addressed in a subsequent section.
 - o 2-1-204(4)(d) Recusal of the Chair Move wording "from the membership of the AAB" from the end of the sentence to the middle.
 - o 2-1-204(4)(e) All members of the Hearing Panel *present at the hearing* shall be voting members.
 - 2-1-204(4)(h) Determination of AAB Hearing Panel Proceedings During a Non-Contractual Period Use "appropriate Dean" in reference to the Dean of a College (UG) or Dean of the Graduate School (GR).
 - 'Calendar day' language will be used where appropriate in this section when referencing non-contractual periods.
 - o 2-1-204(5) Preparations for the Hearing This section refers to the Preliminary

Hearing.

- The Preliminary Hearing is just the Panel. The student and respondent(s) are not present; they are just made aware of the date to follow the prescribed timeline.
- o 2-1-204(5)(a) 'Within twenty-one days' refers to the allotted time *after the approval of the Hearing Panel* by which the parties shall provide information.
 - Information listed in 2-1-204(5)(a)(ii.) is not needed for the Preliminary hearing.
