Reports from Councils:

Graduate Council (Dunemn) – Kim Black and Nancy Matchett attended our last meeting to discuss issues concerning the distinctions between extended campus and main campus courses. We'll be revising our bylaws next semester. The Council recently approved UNC's first CO3 course and reviewed LAC appeals. Assessment planning is coming along.

Professional Education Council (McMullen) – In order to lighten the workload of the full Council, PEC is allowing their leadership team to approve program updates that don't impact matrices. We may add a meeting in December to complete the review of program updates.

Undergraduate Council (Dineen) – We are meeting tomorrow. UGC will be designating a faculty representative to serve on the Engagement Task Force.
