New Business

• Language Use in Academic Contexts

- Kraver brought to the committee an issue that arose in the context of teaching a 19th century literature course.
 - Some readings for the course contain racial slurs. When students are quoting from the text, they may choose to read the language as presented, use another term, or omit problematic words, whichever is their preference.
 - One of the students in the class asked that a particular word not be used at all.
 - The student's concern was addressed through the appropriate channels (Department Chair, College Dean, Title IX and Dean of Students Office).
 - No wrongdoing was found. The language use in the context of the classroom is considered protected speech and is a matter of academic freedom. It is not considered hate speech.
- o Discussion:

- Related issues in other fields of study: examples from History, Music, and more
- Many faculty members include a warning about topics that may make students uncomfortable
- Importance of academic discourse and providing a safe space for difficult issues to be discussed critically
