#### **Call to Order**

The meeting was called to order at 2:01pm.

#### **Approval of the Agenda**

#### **Chair's Report/Announcements**

- We need to check the recent UR/BPM updates.

#### **Unfinished Business**

- Senate Action 1113: Evaluation, Promotion, Tenure
- Review Committees, Boards, and Councils Bylaws
- Faculty Senate bylaws
- Inclusive Pronoun implementation

#### **New Business**

- **Posthumous Degrees (APC)**
  - The committee reviewed APC's revisions to 3-8-104(2).
  - Change "Provost" to "CAO" throughout.
  - Change "towards" to "toward".
  - Change "deceased student" to "decedent" for consistency.
  - Minor edits for clarity in (e).
  - Return to APC.
- **Chair/Director policies (Welfare)**
  - Levin explained the purpose of the proposed changes to distinguish chair/director roles.
    - Any unit leader who has 1.0 FTE in administrative duties will be a director (administrator).
    - Any unit leader who has less than 1.0 FTE in administrative duties will be a chair (faculty).
    - This change would result in many of the unit leaders currently called directors becoming chairs.
    - Also, we are expanding the definition of voting faculty to count faculty service (including chair service) toward eligibility requirements.
  - These updates would result in needing to update policy language in several places in UR/BPM.
  - The proposal seeks to establish policy-wide definitions for the following terms: Academic Unit, Unit Leader, Chair, and Director.
    - Codification shall determine the appropriate placement for the definitions in UR/BPM.

- Note: The local definition of “Unit Leader” in 3-3-201(b)(ii) will need to be updated. Check for other similar updates needed throughout policies.
- The committee began reading through the proposal.
- 2-3-1101(3)(a) Initiation of Proceedings
  - Ask Welfare if there is a step missing in how the process is articulated.
  - Use “CAO” to refer to “Chief Academic Officer”.
- 3-3-301 Chair Selection and Evaluation
  - If the sentence at the beginning of the section is retained, add “free-standing program” to the list of academic unit types.
  - Use “CAO” to refer to “Chief Academic Officer”.
  - Ask for clarification regarding the reference to “one year” (academic or calendar) in 3-3-301(1)(b)(ii).
  - Change “will” to “shall”.
  - Find appropriate reference to cite regarding “the level of evaluation” in 3-3-301(4).
- 3-3-1101 School Director Policy
  - Use “CAO” to refer to “Chief Academic Officer”.
  - Find the appropriate reference to cite regarding “Deans Evaluation” in 3-3-1101(4).
- Continue review next time.
