• Template for new policies

- o The committee created formatting guidelines for placement on Codification website:
 - List any definitions in alphabetical order.
 - Use inclusive pronouns (e.g., "their" instead of "his or her").
 - Use "shall" instead of "will".
 - Follow the standard numbering/letting format of the document in which the policy will be placed.
 - Refer to related policy sections as appropriate.
- o Include a simple explanation of governing documents:
 - Board Policy Manual
 - States University policy in a broad framework
 - Contains Board adopted policies (Title 1) and Board approved constitutions and procedures (Title 2)
 - Requires final approval of the Board of Trustees
 - University Regulations
 - Provides details about how Board Policy is implemented (Title 3)
 - Requires final approval of the President
- o Post the policy proposal template to the Codification website.

• Faculty Senate bylaws

- o The committee resumed review at Article VI, comparing the Salary Equity's current bylaws.
- o Continued edits for clarity.
- o Delete "or appointed" from E., as faculty representatives are elected by the Senate.
- o Ask about the "annual staffing plan".
 - What is it, and is it still called that?
 - Is it distributed to campus?
- o What is the "other appropriate data" in relation to classification using the Decision Band Method (DBM) and CUPA (College and University Personnel Association)?

- o Update the section describing internal parity.
- o The committee will continue review at a later meeting.
- o Once Codification has reviewed the Senate bylaws, we can ask the respective Senate committees to review their individual sections and make suggestions.

New Business

• Inclusive Pronoun implementation

- o Satriana reported that Tiffany Pendleton is working on an initial sweep for pronoun updates.
- o Codification can review the updates when they are ready.

• Conflict of Interest policies

- o In response to a question about the references to various Conflict of Interest policies in the BPM and UR, the committee reviewed the relevant policy areas.
- o The bottom of 1-1-105 Ethical Standards has a large bracket that lists all three Conflict of Interest policy areas:
