Salary Equity (Greene) – We are prioritizing the creation of a new compensation investment plan to present to the BOT at their next meeting. We are refining data on a few different models to reach an average of 100% parity with our NCHEMS 51 peer group in x-number of years.

- Fischer asked to meet with Feinstein and Vollendorf before the BOT meeting to discuss the compensation investment plan.
- Role of Salary Equity to discuss and make recommendations on salaries/parity/equity versus the administration's role in determining what is attainable and how to get there
  - o Payroll is the University's largest expense
  - Caution in building up expectations for higher salaries without examining how to fund increases
  - o Strategic dialogue is needed among many campus groups (including faculty) to examine the budget more wholistically

## **Standing Reports**

Board of Trustees (Fischer) – No Report.

<u>President</u> (Feinstein) – The BOT retreat is on September 24<sup>th</sup>; topics will include Salary Equity's compensation investment plan, the osteopathic medical school exploration, and enrollment. There was good turnout for UNC at the football game against CU. The State of the University Address is tomorrow; a reception will be held afterward.

<u>Provost</u> (Vollendorf) – We are examining our academic portfolio. Deans will launch conversations with chairs and directors regarding enrollment, curriculum, etc. We have work to do in transferability, how we use Extended Campus, how we can adjust to student needs, and how to respond to changes in enrollment. We need dialogue across campus about where we are and where we are going. We need an agenda to stabilize and strengthen the University.
