Senate Committee Reports

<u>Academic Policies</u> (Levin on behalf of Vaughan) – We are continuing work on catalog updates pertaining to GPA and Posthumous Degrees. We'll also be looking at a proposal from the Graduate School to create a Leave of Absence policy. We are waiting for a recommendation from UGC regarding creation of a permanent S/U grading option.

Codification (Schuttler) – We will be reviewing items from Welfare and APC.

Faculty Welfare (Senbet) - The RSCW Misconduct policy has been sent to Codification.

<u>Salary Equity</u> (Greene) – We are continuing revision of the Compensation Investment Plan and rationale; we are incorporating feedback from Faculty Senate and Trustee Babbs. We'll ask for a vote of endorsement from Senate next week.

Standing Reports

<u>Board of Trustees</u> (Fischer) – The BOT met last week to explore the possibility of amending a bond with improved rates of interest.

<u>Provost</u> (Vollendorf) – We are inviting untenured faculty to a reception with academic leaders to promote their sense of community and make connections on campus. We are examining staffing issues across campus and how to shore up staffing support where it is needed.

- Some shortfalls are side effects of the transition to the ASC model; members provided specific examples of difficulties experienced in their units/colleges.
- Schuttler asked about the status of administrative searches for PVA and expressed concern that filling school director roles with internal faculty candidates might burden their units.
- Unlike chairs (who retain faculty status), school directors are administrators and would be vacating their faculty roles.
- The Faculty Welfare Committee will be taking up the question of chairs/directors and the differences between those roles.
