- 1. <u>Call to Order</u> The meeting was called to order at 4:01pm.
- 2. <u>Approval of the May 2, 2022 Agenda</u> Approved without objection.
- 3. <u>Approval of the April 18, 2022 Faculty Senate Minutes</u> Approved without objection.
- 4. <u>Chair's Report</u> (Levin): No Report.
- 5. Administrative Reports:

President (Feinstein): The President asked members about the purpose and context of the annual Faculty Perceptions of Administrators Survey (FPAS).

DISCUSSION:

- FPAS was designed about 14 years ago as a confidential way for faculty to express their perceptions of upper-level administrators (i.e., deans, provost, and president); the survey is not related to any official evaluation procedure.
- Members discussed the FPAS process and how it could be amended in the future to provide more meaningful/constructive feedback.
- Next year, Levin will work with the Faculty Perceptions of Administrators Committee (FPAC) to re-examine and improve the FPAS process.
- **Provost** (Vollendorf): Finalists for HSS Dean and Vice Provost will be visiting campus in early May; candidate information and open forum times are available on the search websites. Thanks to everyone participating in the searches. Also, thanks to everyone for the opportunities to learn and work with you this year.
- **Board of Trustees** (Fischer): This is Fischer's last meeting as Faculty Trustee. Congratulations to Angela Vaughan, incoming Faculty Trustee. The BOT's next Finance and Audit Committee meeting is Friday, 5/6. The next full BOT meeting is Friday, 6/10. Meeting information is posted on the BOT website ahead of time. Fischer encouraged any faculty with comments/questions for the BOT to reach out to him.

Academic Policies (Vaughan): We have two items under new business. Also, the Registrar brought to our attention recent changes to the federal definition of academic engagement (available at <u>https://www.law.cornell.edu/cfr/text/34/600.2</u>). This replaces previous language in university catalogs for "academically-related activity" and "academic

attendance". The new language better reflects what happens in current academic settings and online learning. The catalog language will be updated for next academic year.

• Academic Covid Responsiveness Group Report (Senbet, Vaughan): No Report.

12. New Business

• IEP enrollment status – catalog language (APC)

- Vaughan presented language that clarifies full-time status for students in the Intensive English Program (IEP).
 - The revised catalog language aligns with appropriate federal regulations.
 - IEP students with F1 or J1 visas are considered full-time if enrolled in 18 classroom hours.
 - The Registrar's Office and CIE approve of the language as presented.
- MOTION: APC It is moved to approve the revised catalog language to clarify full-time status for students in the Intensive English Program.
- VOTE: Approved by voice vote.

• **Prior degree credit applicability** – catalog language (APC)

- Vaughan presented language that clarifies existing policy regarding the applicability of prior credit toward a second baccalaureate.
 - There is no change to operational practice.
 - To earn a 2nd BA, students must:
 - have at least 30 additional UNC credits after their first BA, and
 - meet all major requirements.

MOTION: APC – It is moved to approve the revisions to the Second Baccalaureate section of the Undergraduate Catalog.

VOTE: Approved by voice vote.

• Senate bylaws (Codification)

- Codification took up the issue of revising Faculty Senate bylaws after the inclusive pronoun resolution was passed.
- Upon review, the committee found many areas where language could be cleaned up.
 - Removal of the Elections Committee (which no longer exists)
 - Revision to make sentences consistent across the various sections of the bylaws
 - Removal of the duplication of committee duties (where appropriate)
 - Revision of the Salary Equity section to be consistent with current Salary Equity bylaws
- Each Senate committee reviewed and made recommendations for their respective sections of the Faculty Senate bylaws.
- Amendments to the Faculty Senate bylaws require a two-thirds vote and two readings, so we will only be reviewing today, not voting to approve the revisions.

DISCUSSION:

- o Remove the extra prepositional phrase typo in Article VI, J.
- Consider revising the format of the committee membership sections for consistency.

- Note: Membership allotments for Salary Equity and Codification are different from those for Faculty Welfare and APC, which may have a variable number of Senators numbering at least five.
- \circ Levin will take the recommendations back to Codification.
- Haddad asked about the definition of internal parity in Article VI, I. 3. d. and whether it impacts university hiring.
 - There are no impacts on university hiring. The definition of internal parity is used by Salary Equity to examine parity among various university groups.
- We will return to the Faculty Senate bylaws in the Fall semester.

• FPAC Report

- Uglean Jackson, FPAC Vice-Chair, presented the 2022 Faculty Perceptions of Administrators (FPAS) report.
 - The question sets and the report format are the same as in previous years.
 - This year's survey ran for a week in April and included the following administrators who have been at UNC for at least one year:
 - University President survey sent to all voting faculty
 - Dean of the Graduate School survey sent to all voting faculty with graduate faculty status
 - Dean of University Libraries survey sent to all UL voting faculty
 - Dean of the Monfort College of Business survey sent to all MCB voting faculty
 - Historically, the FPAS report is made available on the Faculty Senate website via a link to the FPAC SharePoint.
 - UNC login credentials are required to access the annual report.
 - The numeric scores plus comments (which are not part of the report) will be distributed to the administrator and their supervisor.

DISCUSSION:

- \circ Members discussed adding the following information to the report:
 - Sample size and response rate
 - Cover letter/statement providing context
- MOTION: Vaughan It is moved to accept the 2022 FPAS Report with the condition of adding sample size and response rate before making it available through a private link on the Faculty Senate website; additionally, the FSEC is charged with providing an overall contextualizing statement to accompany the report in a timely manner.
