## **Grade Replacement Policy**

Effective Fall 2013, the specifications of the Course Replacement Policy are as follows:

Courses repeated under this policy may not be eligible for financial aid; for more information, contact Financial Aid at (970) 351-4UNC (4862).

• The Grade Replacement Policy applies to UNC courses that are letter-graded (A-F). The courses must be the same (prefix and number) and both courses must be taken at UNC. The course must not be designated repeatable for credit in the current catalog. Satisfactory/Unsatisfactory (S/U) grades are excluded.

## Recommended policy addition:

Effective Fall 2013, the specifications of the Course Replacement Policy are as follows:

Courses repeated under this policy may not be eligible for financial aid; for more information, contact Financial Aid at (970) 351-4UNC (4862).

• The Grade Replacement Policy applies to UNC courses that are letter-graded (A-F). The courses must be the same (prefix and number) and both courses must be taken at UNC. The course must not be designated repeatable for credit in the current catalog, unless it is a variable title course repeated under the same course prefix, number, and title. Satisfactory/Unsatisfactory (S/U) grades are excluded.
