Part 2 Governance. 1-1-201(2) Board of Trustees (BOT)

1-1-201(2) Student and Faculty Trustees. Pursuant to Colorado Revised Statutes, one trustee shall be an elected member of the student body who is a full-time junior or senior student at the University of Northern Colorado. Their term of said elected office shall be one year, beginning July 1. The elected student office This position shall be advisory, without the right to vote. The elected student member of the board They shall have resided in the state of Colorado not less for no fewer than three years prior to their election. Another The faculty trustee shall be an elected a member of the faculty at large at the University of Northern Colorado, elected by other members of the faculty at large for a term of one year, beginning July 1. and such office This position shall be advisory, without the right to vote.
