

CONCURRENT ENROLLMENT REQUEST

International students may enroll concurrently at more than one school if they have gained approval **before** enrolling in concurrent courses at an institution other than UNC. This form, and proof of admission to the concurrent institution, must accompany the students' written request. This form, once complete and signed, also serves as an appropriate letter of approval from UNC. The following conditions also apply:

- Completing this form does NOT guarantee approval of concurrent enrollment.
- Allow 5 business days for each of the approval below.
- The request must be approved BEFORE classes begin.
- Requests are valid only for the term specified below.
- F & J visa students may only enroll in SEVIS-approved schools.
- F & J visa students must maintain full-time status during the fall & spring terms. Additionally:
 - 50% or more of credits for semester must be taken at UNC.
 - Submit a copy of your schedule after you enroll.
 - Submit a copy of your transcript showing the letter grade after completion.
