**Procedures:** Faculty members apply for this status *prior* to their retirement from the University through the current graduate faculty procedures. The form is initiated by the retiring faculty member who then electronically submits the completed application to his/her chair/school director; the application is reviewed by chair/school director and forwarded to college dean; college dean reviews and forwards to Graduate School for consideration by the Graduate Council.

**Criteria for Eligibility:** The RGF and RGF/DRE status allows faculty members, upon retirement, to teach, serve as committee members or serve as doctoral research advisors to their doctoral advisees assigned at the time of the faculty member's retirement.

**Applicants for RGF and RGF/DRE must meet the following criteria at the time of application:**

- (a) be a member in good standing of the Graduate Faculty;
- (b) hold an active GF or GF/DRE status confirmed by the Graduate School.

**RGF/DRE applicants: In addition to the criteria (a) and (b) above must meet the following at the time of application:**

- (c) have attended a DRE workshop within the past three years. Applicants for RGF/DRE status who have not attended a DRE workshop in the previous three years must complete the DRE workshop *prior* to turning in the RGF application. If the applicant fails to attend a DRE workshop he or she must enlist a co-research advisor for any current doctoral research committees and only be considered for EGF status.

RGF status

RGF/DRE and RGF status is approved for one 3-year non-renewable term. Retired faculty members who wish to teach beyond this three-year period must apply for Graduate Lecturer status

**RGF** status allows a retired faculty member to teach graduate courses and serve as a doctoral committee member. It does not allow the retired faculty member to serve as a research advisor or co-research advisor.

**RGF/DRE** status allows the retired faculty member to teach and serve as a research advisor student assigned at the time of retirement, no new research advisor appointment after the retirement date will be allowed.
