History Day at the University of Northern Colorado Northeast Regional Competition for National History Day in Colorado

Narrative Prospectus

History Day at the University of Northern Colorado is a regional affiliate of National History Day (NHD) and National History Day in Colorado (NHDC), a non-profit education organization that aims to enhance research and critical thinking skills in middle and high school students. NHD annually hosts competitions that challenge 700,000 students and 40,000 educators across the country to strengthen their research, writing, and presentation skill through the creation of a themed history project. Last year, 15,000 of those students came from Colorado alone. The 2017-2018 school year will mark the University of Northern Colorado's thirtieth year hosting the Northeastern Colorado regional competition. The Northeastern region covers all school districts within eight major counties: Larimer, Logan, Morgan, Phillips, Sedgwick, Washington, Weld, and Yuma. Any student in grades six through twelve within these counties is eligible to participate at History Day at UNC.

History Day is an inclusive program intended to build self-confidence and give students the building blocks for a bright academic future by fostering important skills including critical thinking, primary source research, writing, and public speaking. To better enable students to think outside the box and harness their own academic creativity, the program selects a broad theme each year which is not restricted to a particular era or region, and students can select from five project types with which to present their original research which allows equal opportunities for success to all types of learners. In order to ensure that no socio-economic or educational circumstances prevent any interested students from participating, History Day at UNC requires only a minimal registration fee (\$4) and provides supplies and sponsorship to those who need them. Monetary awards and scholarships are available at the state and national levels of the competition for both students and teachers to help them continue their good work in the future.

The 2016-2017 year was one of transition for History Day at UNC. To ensure the program was as competitive as possible, we researched regional coordinator responsibilities and pay scales within the National History Day program. We determined that the job had not been done effectively in the past and compensation was well below the average. In response to the findings, the program requested a higher amount of funding compared to prior years. Because the work of the position exceeds that which could be done effectively by someone with a full-time load, we continue to believe that it is necessary to hire someone to perform the work. Jamie Fogg, an adjunct professor in the History Department, accepted the position as coordinator in June 2016 and reconstructed the position to encourage higher performance and participation in the contest. The primary goal was to both expand the program and to improve existing relationships with schools that participated in the past. Ms. Fogg worked throughout the summer and fall to implement changes that would allow for immediate growth and improved satisfaction.

The changes were effective. The 2016-2017 contest took place March 4th, 2017 and hosted more than 300 students from several districts, making it the largest History Day at UNC

competition to date. The 2016-2017 theme was "Taking a Stand in History," and students produced impressive projects that spanned the globe and encompassed events from ancient times through September 11th, 2001. Ninety-eight students will compete at State on May 5th, 2017, where they will have the opportunity not only to advance to Nationals in Washington, D.C., in June but to also take part in a leadership program over one week in July in Maryland and join with other student groups in traveling abroad to talk about History Day with other international programs. In 2016, for example, several students who advanced to Nationals traveled to France and hosted a Remembrance ceremony for soldiers in World War Two on the beaches of Normandy. During that time, they worked with students their same age from multiple schools in France, promoting an exchange of ideas, cultures, and understandings that go beyond the classroom.

The goal for History Day at UNC moving forward is to continue to grow and expand to additional districts in order to offer these chances to as many students as possible. History Day at UNC also organizes an annual Teacher's Workshop for educators whose students participate in the History Day competition, providing them with a variety of strategies that address incorporating both History Day projects and primary source research more generally into their classrooms. National History Day in Colorado (NHDC) has also worked diligently to ensure that the project process satisfies the Colorado State Academic Standards in Social Studies, Reading, Writing, and Communication, to better allow teachers to incorporate the process into their own curriculum and classroom time. In addition to providing educational service to students and educators, hosting the competition also represents a unique opportunity for members of the UNC community to reach out to students who will soon be applying to colleges and pursuing their own paths in higher education. In the past, representatives from our libraries, various departments, and from Admissions have taken part in the day in order to have the chance to reach out and talk to young scholars about what the University of Northern Colorado has to offer. In 2017, Dr. Laura Connolly, Dean of Humanities and Social Sciences, attended the award ceremony and spoke with students.

Plan and Demonstrated Need:

Fall 2017:

The fall semester is a crucial time for the History Day program for community outreach. It is in these months that the Regional Coordinator (Jamie Fogg) makes most school visits in order to discuss the program with interested teachers and students, and communicates with other members of the local community about judging and other volunteer opportunities. The annual Teachers' Workshop also takes place in the fall, which requires the organization of venue, supplies, food, and presenters. History Day partners with the librarians at Michener Library to host this event. Funds from the prior year's entrance fees are used to finance the food and supplies for the workshop.

Spring 2018:

The National History Day in Colorado Regional competition at UNC takes place each year in March. The Regional Coordinator is responsible for scheduling a minimum of two "Research Rendezvous" sessions, which offer guided research opportunities for participating students and teachers. These are typically held on a Saturday; due to increased demand, UNC

offered six sessions in late 2016 and early 2017 at Michener and Centennial Libraries, and because of the positive feedback will continue to provide the increased number in the future. The Regional Coordinator continues school visits when requested to provide further information and feedback on projects as they progress, recruits judges and other volunteers for the event, creates the registration databases and schedules, and ensures that all necessary technology and space have been appropriately reserved. Funding will provide supplies, food, drinks, and awards for the students, teachers, and volunteers who participate; it also provides for the many hours of work by the Regional Coordinator. In May, the Regional Coordinator serves as a judge and regional representative at the State competition held at CU Denver, and may be requested to attend the National competition in Washington, D.C. in June if students from the Northeastern region advance to that level.

Budget Justification:

- 1. Non-Personnel Costs: Food, awards, signage, and office supplies (including postage) will be used to supply needed materials for the day of the competition as well as all judging packets and further information, which will be sent out via mail. Costs incurred during the fall semester, including the Teachers' Workshop, are paid for using the entrance fees from the previous year.
- 2. Personnel Costs: Based on research of average pay scales for similar positions, the Regional Coordinator pay has been set at \$16/hr for a total of 400 hours: 160 in the fall (12 hours per week for 5 weeks and 10 hours per week for 10 weeks), and 240 in the Spring (20 hours per week for 9 weeks, and 10 hours per week for 6 weeks).
