Research in Progress

"Colorado Pretrial Assessment Tool Validation Project" (On-Going).

Since 2018, Victoria Terranova and I have been working with the State of Colorado to validate and revise the Colorado Pretrial Assessment Tool (CPAT). The CPAT is administered during the booking process in jails throughout Colorado. The tool is used to help judges make bail decisions. We were tasked in testing the predictive ability of the tool, gathering feedback from stakeholders throughout the state about their perceptions of the tool, and creating and piloting a revised version of the tool. This project was supported from a grant from the State of Colorado and numerous internal funds from UNC. The project will be completed in summer of 2020.

"Designing a Structured Decision Making Tool for Weld County's Community Corrections Board" (On-Going).

In Colorado, if an inmate serving a sentence in a State Correctional Institution (a prison) wishes to be released to a community corrections institution, he or she must be screened by a local Community Corrections Board. These boards are made up of criminal justice stakeholders and community members who are tasked with making a decision of whether or not to allow an inmate to be released to these facilities. Due to HB 18-1251, all community corrections boards have been required to develop a structured decision making tool in their screening of offenders into community corrections programs. For this project, we are working with Weld County's Community Corrections Board to help develop and test this tool. This project was funded by a grant by Weld County and will be completed in the summer of 2020.

"Focus Reentry: Evaluation of a jail to community reentry program in Boulder County" (Writing Results).

Focus Reentry is a jail-to-community based reentry program that serves individuals returning from the Boulder County Jail. I have been working with this program since 2016 to evaluate their program. This evaluation is being conducted in two phases. The first is a retrospective impact evaluation from 2012 to 2016 to evaluate the program's effect on recidivism compared to two control groups. The second is a needs assessment involving interviews, observations, and surveys of multiple stakeholders involved in Focus Reentry. This project will be completed in the Spring of 2020.

"Practitioner Perceptions of Pretrial Risk Assessment Use and Utility: Focus Group Analysis" (Writing Results).

Pretrial release is an important decisions that are made within the early stages of the correctional process. Pretrial risk assessments are often utilized to assist courts in determining whether a defendant should be released prior to their court date. In the current study, a series of focus groups were conducted across seven participating counties in Midwestern state to gather input from judges, prosecutors, defense attorneys, pretrial professionals, and other criminal justice stakeholders regarding their perceptions of the use and utility of a statewide pretrial risk assessment tool. This tool is utilized to determine the risk of releasing defendants back into the community while their case is pending. Focus group questions pertained to stakeholder perceptions of the pretrial risk assessment, how it is utilized, and how it could be improved. Results indicate that stakeholders have differing viewpoints about the overall purpose and effectiveness of risk assessment. Five themes emerged relating to 1) the role of the risk assessment tool, 2) how the tool is used, 3) informing pretrial supervision and outcome, 4) consideration of other factors, independent of the risk assessment, and 5) training and education for tool.

"Project SMART: Jail Reentry Challenges in Real Time" (On-Going).

The purpose of this study is to collect data on returning jail offenders in their natural

environment in-the-moment. Working with the Boulder County Jail, this study aims to collect data on returning inmates to understand the challenges they face in real time using a novel methodological approach known as Ecological Momentary Assessment (EMA). Returning inmates will be provided smartphones upon release from jail and answer short surveys, multiple times a day for a month. This is the first time this methodology has been adapted to a criminal justice population.

"r/Excons: A Thematic Content Analysis of Online Communication and Social Networking among Former Inmates" (Writing Results).

From the website Reddit, a network exists where individuals can communicate about their experience in the reentry process, ask for advice, and vent about challenges. A colleague and I have conducted a content analysis of the topics covered to uncover what there individuals discuss in this anonymous online space.

"Reading for a Change Program" (Writing Results).

Since 2016, I have been running a program titled "Reading for a Change" out of Weld County Jail. The program involves student volunteers and myself going into jails (now operating out of Weld and Boulder County Jails and Weld County Work Release Center) and recording incarcerated parents reading books to their children. The recordings and books are then sent home. We also conduct interviews with parents discussing their relationship with their children and how incarceration has impacted their relationships.

"Rural Jail Reentry" (Planning).

Individuals leaving jails and prisons and returning to rural areas often face challenges that differ from their urban counterparts. I have conducted research on these challenges in rural Pennsylvania, and am working to expand this research to rural, eastern Colorado. I have been negotiating access to rural jails to interview or survey inmates and these challelnges.

"The Impact of Cannabis Legalization" (Writing Results).

i have been working with Dr. Brian lannacchione and Dr. Mary Evans on numerous projects related to the impact the legalization of cannabis has had on Colorado, Washington, and their surrounding states. These studies have involved surveying dispensary owners and police. There are currently three papers and one book chapter being written from data collected on these projects.
