

### **INTERNSHIP PACKET (CRJ 492)**

This packet contains information and forms needed for enrollment in CRJ 492 Internship at the University of Northern Colorado. This information is also available on the Criminal Justice Department website, which may be accessed at https://www.unco.edu/hss/criminology-criminal-justice/students/internships.aspx

- 1. **Enrollment and Course Requirements** This document contains the internship course description, information about prerequisites, enrollment information and course requirements.
- 2. **Internship Application Form** Internship applicant must complete and submit this form prior to admission in the internship course.
- 3. Internship Application Form Internship applicant must complete the top section:
  - a. Student name;
  - b. Bear number;
  - c. Bearmail address

Student must then take the form to the Internship Site Supervisor for completion of the bottom part of the form. This should include the following:

- a. Semester that the internship is to take place;
- b. Number of contact hours to be completed by the student intern;
- c. Agency name and contact information;
- d. Agency Site Supervisor's name and contact information; and
- e. Site Supervisor's signature and date.

NOTE: This form MUST be received during the registration process before you can be enrolled in the Internship course. No late registrations will be granted.

- 4. **Internship Hours Log** Once accepted as an intern, this form must be completed and approved weekly. It shall be submitted at the end of the semester to the Internship Coordinator.
- 5. **Internship Final Evaluation** This form must be completed by the site supervisor and submitted at the completion of the semester to the Internship Coordinator.

All forms must be submitted in one of the following manners:

The student can enroll for 3, 4,5, or 6 credit hours.</li> <li>The student must log the completed work hours each week on the Internship Hours Log and provide a brief explanation of the duties/activities with the agency during the week. This will be completed on an Internship Hours Log.</li> </ul>   |
| <ul> <li>At the conclusion of the internship, the student must submit a 2-4 page report that provides an overview of their internship experience, indicates the similarities and differences between the internship experience and material from relevant criminal justice courses learned, and how this experience has influenced the student's career goals.</li> <li>The student must receive a satisfactory final evaluation from the Field/Site Supervisor.</li> </ul>   |
| <ul> <li>Agency Field/Site Supervisor Responsibilities:</li> <li>Each week, the Field/Site Supervisor must approve the completed work hours on the student's Internship Hours Log.</li> <li>During the semester, the Field Supervisor may be contacted and asked to provide feedback regarding the student's progress thus far. Obviously, the Field Supervisor is also welcome to contact the Internship Coordinator any time during the semester if questions or problems arise.</li> <li>Near the end of the term, the Field/Site Supervisor will be asked to complete a one-page evaluation form that will be used to determine whether the student completed the internship in a satisfactory manner.
