Research in Progress

- "Another Test of the Group Hazard Hypothesis" (Writing Results).
 - Erickson (1971) and Hindelang (1976) tested the "group hazard hypothesis" and found a greater arrest risk for group offenders (those who violated the law in groups), as compared to solo offenders. Recently, Tillyer and Tillyer (2014) used data from the National Incident-Based Reporting System (NIBRS) and found a greater likelihood of arrest for non-fatal robberies committed by group offenders, as compared to those committed by solo offenders. Expanding on the research of Erickson (1971), Hindelang (1976), and Tillyer and Tillyer (2014), the present study tests the group hazard hypothesis with NIBRS data for multiple offenses assault, robbery, and sexual offenses. Implications for use of official crime data and understanding the causes of crime are discussed.
- "Devil is in the Counterfactual: Alternative Strategies for Evaluation Study" (Writing Results). There are diverse ways to evaluate treatment effects with non-experimental data. At least part is due to examining different questions with different counterfactuals. Data from a study of the effects of an ignition-interlock device on DWI recidivism, where convicted offenders used the device during (1) a pre-probation period only, (2) a probation period only, or (3) both a pre-probation and a probation period, were used to create different matched

comparisons by propensity score matching. For example, offenders who used the device only during a pre-probation period were matched with a control sample comprised of convicted DWI offenders who never used the device. These same offenders who used the device only during a pre-probation period were also matched with a sample of offenders who used the device only during a probation period. There are many possible comparisons of this type, addressing different questions and different counterfactuals. Seemingly similar comparisons can produce different conclusions about treatment effects, and no particular type of comparison is more valuable than another. However, some questions and counterfactuals are more useful for policy decisions, while others are more academic. These issues are considered in terms of their implications for understanding evidence about treatment effects with non-experimental data.
