- Mathematics & Natural Sciences (Steele) OCEAN 110 has not been taught since Fall 2023, and that syllabus lacks criteria. They have a Fall 2025 syllabus, which will be reviewed. Steele will send the Fall 2025 syllabus to Margaret.

New Business

- UNC General Education Foundational Skills Credential
 - o CDHE Foundational Skills Website URL
 - UNC Foundational Skills Credential Talking Points
 - o There is some general reluctance to the rationale provided for utility.
 - o Could be awarded as a transcript recognition maybe associated with badging.
 - o BC how likely would it be to get a badging tool?
 - NJM: APC has charged a micro-credentials committee to make recommendations about the process.
 - The idea is to have a policy and strategy in place before purchasing the badging tools, which could be in Fall 2027.
 - It currently seems likely most badges would have a fee. Fee not mandatory for all students only if they want the badge.
 - \circ BC is there a way to have an application process?
 - Registrar: There could be, based on procedures established the CORE initiative
 - They have systems that are able to run internal checks for eligibility
 - o Registrar: There is a chance several students would qualify historically similar to CORE.
 - How far back in time do we want to go?
 - Depending on timeframe several hundred students would qualify.
 - Students who met the 31-credit requirement but walked away from UNC would qualify.
 - o This could be seen as a re-recruitment tool.

- The registrar has systems in place where they can mirror the CORE project just need to determine how far back to go
- o Moving forward this ould be an "auto-award" for those that are qualified
 - They will need about a year lead time with a realistic start time of Spring 2026
- Chair: What does the committee think about going back a few years?
 - If it's not too much work, it may work to mirror CORE
 - For historical aspect registrar would ask the students "if this were something they want?"
- Another option is to award as a certificate
 - There is no conversation on certificates larger than 12 to 18 credits which might make pushing in that direction difficult.
- Bebee consulted several sources
 - He started with literature, which is developing and interesting.
 - His second approach used research aspect of ChatGPT4.0
 - Lastly, he spoke with people who do offer certificates similar to this
 - Several were in the community college system in the Midwest
 - Some institutions will be sending him their data
- Research is sparse and hard to find good data.
 - However, intermediate awards do promote student success and a morale booster. It signals to employers that these students can do college work
 - There are a number of communication factors that when marketed correctly employers would be more likely to hire.
 - Students with certificates are more likely to go back to finish their degree.
- o There is no national data, but it is very common in the community college system.
- Muller would like to bring a recommendation to Academic Policies Committee (APC) since this conversation may be happening in APC soon
 - The question of setting residency requirements was raised, since high school students are coming in with several credits from several places.
 - There were concerns about the term "interim", since the registrar uses specific notation.
- MOTION: Casey motions that the LAC endorses a transcript notation of a foundational skills credential with a letter that can be supplemented by a badging system, seconded by Harris.
- o VOTE: Approved unanimously
- o The letter will highlight the skills and will serve as an informative document that could be added to the LAC website
 - This would be a forward-facing part of the website.
 - Idea is to move students away from thinking these requirements are just checking required boxes and be excited to gain these skills
- o NJM: With the question of going back in time, feedback will be needed from Pete Lein
 - The council is open to going back a few years
 - The registrar stated that it would be coding logic and something they can do
- O Discussion of Three Different Criteria Sets for Award Talking Points
 - Suggested Award Criteria aligns with State gtP Competencies:
 - Anything that fulfills gt pathway would count including dual enrollment
 - Current policy reads that a student can fulfill a credential we offer with transfer credits as long as they enroll as a UNC students
 - Gtp credits only transfer with a C or higher

- o MOTION: Casey motions that the UNC foundational skills credentials criteria be as proposed with including IS/MS classes or SBS 2/3 courses, seconded by Nancy G.
- o VOTE: approved unanimously
- o Nancy M. will revise the document with an update on FAQs and credits. Once finalized she will share with APC and have it available in a Teams folder.
- Moving forward:
 - The structure of the letter will need to be determined.
 - The website will need to be updated.
 - Jordan Smith has volunteered to join the outreach & communication committee.
- CO2-CO3 Clarification Operationalization <u>Memo</u>
 - o The LAC will provide the resources for the transitions to a LAW3
 - Tara Wood will be the main contact.
 - Casey stated that faculty in PVA think students won't take a PVA writing course if it is LAW3.
 - Brownlee shared that English requires the ENG LAW3 writing course in one of their majors.
 - O How do we announce?
 - A general announcement can be made through the Academic Affairs newsletter but may want to hold off until we get closer to the actual transition.
 - We will need to see the timeline and an announcement should be made in the Fall.
 - Memos can be sent out this spring.
 - Who do we contact for the memos?
 - Unit leads which in this case are A-Deans.
 - Can it be added to the new website roll out?
 - Yes, it will be part of the website
 - Having it on the website might be the first-place students look.
 - A note will be added in in the email for the contributions memo to be sent out during spring 2025 to all units with LAC courses.
 - O The current timeline from the fall motion will remain unchanged for now.
 - The goal was to provide a broad timeline.
 - Members may want to discuss it further with their units.
 - Harris has already had some conversations in MCB.
 - Some units may prefer to complete it earlier.
