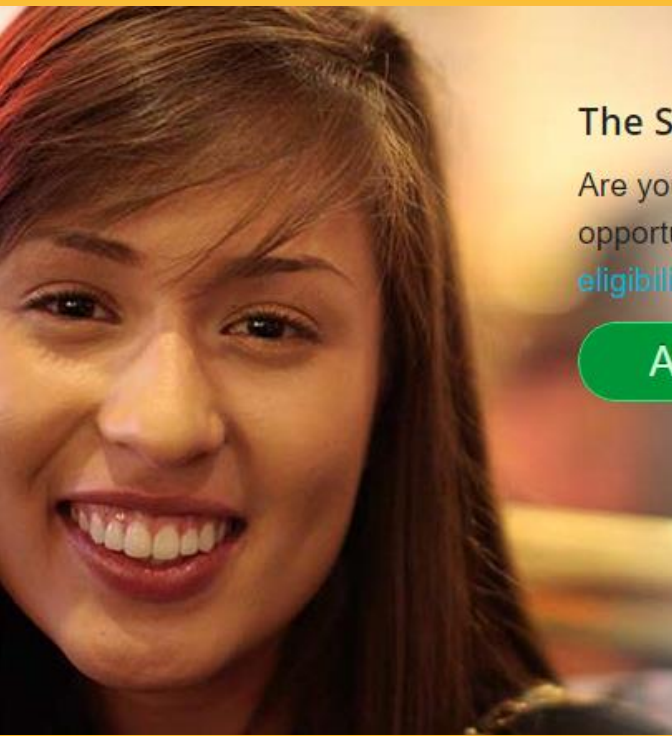

A/R REFUNDS

A/R REFUNDS

The amount refunded from a balance left over after financial aid has applied to the student bill

- 1 Financial Aid disburses to bills the Friday before classes*
- 2 Refunds available 2-3 business days after disbursement in check form at the Bursar's Office**
- 3 Refunds from a Parent PLUS Loan will be mailed in check form to the parent if requested during the initial application

Don't Want a Check?

Students can request to have future refunds **direct deposited** into their bank of choice through the Payroll Office

**Financial aid will not apply to the bill if student has outstanding requirements or holds on their account*

***Time may vary if using Direct Deposit as some banks may take longer to receive the funds*

FINANCIAL AID **FAQs**

DISBURSEMENT PROCESS

- 1 Submit any outstanding documents
- 2 Students notified of an award letter
- 3 Complete **Terms and Conditions**
- 4 Accept or Decline awards
- 5 Aid disburses weekly

SECURING LOANS:

First time borrowers must complete Entrance Counseling and a Master Promissory Note

PARENT PLUS **LOAN**

Know Before You Owe:

- ❑ Cost of Attendance – all other financial aid = Parent Plus Loan
- ❑ Must pass a **credit check**
- ❑ **Repayment** begins after final disbursement
- ❑ Parent Plus Loan **denial** options
- ❑ 2018-19 interest rate is **7.595%** and starts accruing at disbursement

Borrowers

Only a biological or adoptive parent can apply for the Parent Plus Loan

Returning a Loan

Students and parents have **14 days** after disbursement to return loan funding

Endorser

Applicants can apply with an endorser if unable to pass the credit check requirement

MAINTAINING YOUR AID

SATISFACTORY ACADEMIC PROGRESS (SAP)



SAP

Students must be making SAP to receive financial aid funding.

- 1 Minimum 2.0 **cumulative** GPA
- 2 Complete 67% of attempted credits
- 3 Achieve degree prior to 180 attempted credits

MOST

grants and scholarships require a student to be enrolled in at least 12 credits

INELIGIBILITY

- WARNING** semester if below the 2.0 GPA and/or 67% completion rate requirement
- INELIGIBLE** if requirements are not met for two consecutive semesters
- INELIGIBLE** if completes zero credit hours (withdrawals) and/or cumulative GPA falls below 1.0 in a single semester






Students ineligible for aid may submit an appeal to the financial aid office

IMPORTANT FINANCIAL AID DATES

- Aug. 1st** View fall tuition/fees on URSA;
First available day to apply for **Bear Pay**
- Aug. 2nd** August eBills available (financial aid will not be on the first fall bill)
- Aug. 15th** Financial aid will begin showing up on the bill
- Aug. 17th** First day fall financial aid refunds will be available
- Aug. 20th** Classes start
- Aug. 31st** Fall bill due
- Oct. 1st** First day students can complete a **FAFSA**
- Nov. 1st** First day students can complete the **UNC Scholarship Application**
- March 1st** **UNC Scholarship Application** and **FAFSA** priority deadline
