#### 6. Old Business –

• **Recognition Event Wrap-up:** Libby Klingsmith, Becky Broghammer, Michele Tyson – Reported that we had fairly low attendance at this event compared to other years. There was some discussion about whether the change of location may have contributed to the low attendance. The possibility of combining our recognition event with SPEEC's event was also discussed. There was some confusion about the start time of the event this year, with some people arriving at 11 a.m., with lunch not being

served until noon. We also discussed the mechanism to determine who is recognized and the possibility of changing the timing of the event to fall rather than spring.

#### 7. New Business –

• **Discussion of Administrative Salary Setting and Salary Equity Plan**: Rene Oya shared an update from Faculty Senate. They have worked out a transparent five year process for determining salaries each year. Three factors are computed: base salary, parity and merit. It is a system that also uses years in the position. Faculty will receive a 4.5% raise next year. Thirty-four faculty have left this year.

Nancy Gray shared potential recommendations regarding exempt staff salaries and benefits. There was some discussion about the need to properly identify institutions that should be considered peer institutions, as well as aspirational peer institutions-schools we want to aspire to be like. Gray said she and Joan Lamborn would be happy to continue as members of the compensation committee, representing the interests of exempt staff.

- Replacement of PASC Members Michele Fargher and Amanda Garcia: Vicki Mossman will look at the election results to determine other individuals we might recruit since we have lost Michele Fargher and Amanda Garcia.
- **Election of Officers for 2007-2008**: Scott Schuttenberg and Michele Tyson will tentatively serve as co-chairs. Jay Dinges will serve as treasurer and Sarah Chase will serve as secretary.
- **Next Meeting**: No meeting is scheduled for July. The August meeting date, location and time will be announced later.
