3) New Business

Invites went out to milestone recipients and Employee of the Year nominees as well as their supervisors/nominators. The Executive Committee will call those who have not RSVP'd. Puckett shared there will not be a lot of decorations due to cost. We will have vases with flowers that will be given away at the end of the event. There will be name tags for attendees. Croissant will work the check-in table. Little Owl and Sappington will assist J. Tort with award set up. Michelle Quinn is covering the cost of the awards and a continual plaque that will be posted in the PASC display case in Carter Hall. Barry Lapoint will do photos.
- Elections Eighty-five (85) election ballots were completed and returned. The individuals with the six highest scores are Jacqueline Auker, Joe Tort, Frances Braafhart, Kelley Christman, Julie Tacker, and John Wieser. J. Tort will contact the new PASC members and invite them to attend the May meeting. Sappington and J. Tort will contact the other nominees and ask if they would like to participate in committees next year even though they are not formally on PASC.
- **Planning Meeting in May** PASC's 2010-2011 term planning meeting will take place during our May meeting. We will move this to the middle of May and extend it to two hours. Dutmers thought PASC could afford to cover lunch that day.
- **State Budget** The University is trying to put together a \$14 million reserve budget for 2010-2011. House Bill 146 mandates that employees will now pay 10.5% towards retirement which means each individual in PERA will notice a

- 2.5% decrease in their take home pay. As of now this is for a one year period although it may be extended for longer. 175 (55%) exempt employees at UNC are in PERA. Employees in TIA/CREF, Valic, MetLife or other retirement plans will not have a decrease at this point.
- UNC Sexual Harassment Policy Stephen Luttmann, Chair of Faculty Senate, joined us today to discuss UNC's Sexual Harassment Policy. Luttmann shared a copy of the draft policy. There is no discrete policy for reporting sexual harassment at UNC. It was initially included under the general discrimination procedures. Luttmann explained specific aspects of the policy. The Council members discussed the policy with Luttmann.
 - PASC will add a comment in their bylaws on how they will assign exempt employees to serve on a panel when/if sexual harassment charges are filed against our peers.
