- 1. Call to Order Meeting was called to order at 11:10 AM
- 2. Approval of the Minutes September 6, 2012 meeting minutes approved
- 3. Higher Learning Commission (HLC) Presentation Michelle Behr (2 handouts)
 - a. HLC accreditation visit is important for financial aid, transfer and degree recognition and required for grants
 - b. HLC self-study is a series of standards and criteria outlined by the commission, along with the UNC mission and its interpretation by the university. The President Norton is also using this opportunity to ask institutional question(s).
 - c. HLC provides requirements that all institutions must have for accreditation and the Federal Government has charged the commission to make sure institutions are in federal compliance for federal funds. The expectation of the commission is that there is an awareness across the university and that there is a university community involvement in the process.
 - d. Question: With the state providing less funding, will that impact state oversight? Answer: Probably not
 - e. Question: What is being done to insure that conversations that matter and university community involvement are occurring? Answer: There was a broad call for volunteers to serve on the various criterion committees, there are staff and faculty on all committees, there will be focus meetings and the criterion committees have been charged with doing outreach across the campus.
 - f. Question: What is the future process for HLC visits? Answer: depending on the outcome of this visit there will be points in time that the university would need to provide information. Ideally there would be a midpoint (5-Year) report which would roll-up to the 10 year full accreditation visit.
- 4. Center for the Enhancement of Teaching and Learning (CETL) presentation David Kendrick and Tabby Harraf (2 handouts)
 - a. Kendrick explained the purpose of the CETL
 - b. Harraf presented information concerning Skillsoft It is free to UNC employees and contains training courses/webinars, etc. on software, human resources, leadership, etc.
 - c. Question: How often are courses updated? Answer: They are updated frequently and if there are areas that employees would like they can email Tabby to request it be added
 - d. Question: Is this available to student employees? Answer: UNC generated information can be used by student employees and specific courses can be assigned to student employees. The student employee name would need to be sent to Tabby along with the courses.
