

## **PASC Business Meeting Minutes**

June 15, 2016 11:00 AM – 12:00 PM South Hall Lounge

- 1. Call to Order 11:02am-Mahoney
- 2. Status of Accounts (as of 5/30/16)-Gomez
  - Operational \$2070.03
  - Foundational
    - 10960.14
    - \$410.97 (remaining funds in this account will be used for book scholarships; this account should no longer have funds deposited after 7/1/16)

## 3. HR Report-Parks

- New FLSA overtime rules now in effect; deadline to implement is December 1. Federal yearly income threshold is \$47476 or less
- Approximately 300 employees are now eligible for OT (many UNC employees have previously received OT; this figure is newly identified employees)
- Marshall will meet with supervisors of eligible employees over the next 4-6 weeks to determine best way to implement tracking of OT
- HR looking at using TimeClock+ for time entry
- Federal law allows for 480 hours to be accrued and used as comp time rather than being paid as OT; UNC is looking at an 80 hour comp time maximum before paying OT
- HR will send a letter out to employees around 9/1 with more detailed information
- 4. Transitional meeting will be July 6 from 8.30-12 @ Holmes Dining-Mahoney
  - New council will have taken the Strengths Quest Assessment
    - Strengths Quest is an assessment that provides a person with a Signature Theme Report highlighting their top 5 talents
    - Renee Welch from Career Services spoke briefly on what Strengths Quest can do for PASC and she will be at the transition meeting to go over the results
  - PASC Committees and Campus Committee Liaisons will be determined at transitional meeting
