

## Order of Business 40<sup>th</sup> Administrative Minutes Zoom, 5:30PM September 2, 2020

- I. Call to Order
  - a. Meeting began at 5:31pm
- II. Roll Call
  - a. 18 of 19 voting members present.
- III. Special Reports
  - a. President Andy Feinstein @ 7:00pm
    - i. The last six months have been very difficult for everybody and it is a very different experience for all college students and UNC leaders.
    - ii. Q&A:
      - 1. Q: The cultural studies department in Candelaria recently has been downsized. How are you supporting and promoting their program to ensure the downsize doesn't hurt the educational opportunities Africana studies, Mexican-American studies, etc.?
        - a. Feinstein is not micromanaging departments and programs. Not aware and not making decisions on program size and program resources. It is department-level decisions. At the college level, we've had to reduce budgets because of COVID-19. We have 9% less students this semester, so there are less classes being taken.
        - b. The value and importance of Mexican- American Studies and Africana studies. It is important to have study spaces and social spaces for these programs. Feinstein wants to know if there is a demand for classes that UNC is not meeting.
      - 2. Q: Thank you for the email about the hate crime that occurred about a week ago. Even if it doesn't turn out to be a true hate crime, what are you and the university doing to make sure students of color feel safe on campus especially in the current political climate?
        - a. Feinstein was furious at the preliminary information of the hate crime on campus. The Greeley PD had a press release that said Feinstein's statement contradicted the evidence that they had. Feinstein met with the police chief. The investigation was early and had not collected information from victim or witnesses. There was no corroborating evidence that it was a hate crime. The Greeley PD just released that they don't think it was a hate crime incident.
        - b. It has to start with leadership discussing what equity, diversity, and inclusivity means to UNC. It is going to go into hiring procedures. It's about educating our community

- it's not happening on our campus; it is in the community. It's about advocating for the emphasis of diversity and inclusion on our campus.
- c. Measurable things we can look for: 1) mandate equity, diversity, and inclusivity training for all faculty and staff, 2) the diversity of our faculty and staff as we hire new employees, they reflect our student body, 3) How President Feinstein interacts within the UNC community (we are on the cusp of being a Latinx-Serving Institution—we want people of color to choose UNC).
- d. Hiring a faculty member- is purview of the college. Convene a search committee.
- 3. Q: What are we doing to accommodate this campus for students with disabilities? That is, how is this university making sure its students with disabilities are being taken care of?
  - a. We have a disability resource center and we try to meet accommodations. We can improve.
- 4. Q: What is being done to prevent the amount of people from making unsafe choices on campus playing games in the lawns without masks while being in extremely close contact with others?
  - a. Self-policing. We all have social responsibility. Besides getting sick, which is terrible, but being stuck in your room for two weeks.
- 5. Q: Very honestly, how optimistic are you about this campus staying open through the rest of the semester?
  - a. I am hoping we are able to operate how we are operating right now. 20-30 people getting tested/day. Optimistic that we are going to be able to get to the end of the semester. Scale: 1(close tomorrow)-10 (end of semester) = 8.
  - b. Testing all students as they come in is not good guidance. It is not stopping the spread of covid-19. It creates a false sense of security. It is a marketing ploy.
  - c. Thanksgiving break closures: majority of other schools have students coming out-of-state. UNC students are usually local from Colorado.

  - i. Southern wing of Frasier gender neutral bathrooms. Severe accessibility issue! There is a petition about this going around. We just need a sign change so that the bathroom is usable by anyone. Dean's office needs to pick the bathroom and pick the signs. We need to start looking at inclusivity as a whole!
