A. FY22 Audit & Athletics Financial Report

- 1. Vice President Dale Pratt introduced auditors from RubinBrown: Matthew Marino and Kelly Witte. M. Marino took the floor at 1:35 p.m. to discuss FY22 financial audit. This included discussion on UNC's net position, PERA pension funding, recent legislation and its impacts to financial statements, fluctuating liability, cash position increases, and status of COVID funding. Discussion ensued through 1:55 p.m.
- 2. Matthew Marino continued his report on NCAA Procedures at 1:56 p.m. This included discussion on no findings issued as a result of the procedure, with compliments to the management team by RubinBrown, on how no NCAA audit on expenditures that are less



than 4% of the budget is managed throughout the year by the University. Discussion ensued through 2:03 p.m.

- B. FY23 Q2 Financial Report and Forecast
 - 1. Vice President Dale Pratt began his presentation on the FY23 Q2 financial report and forecast at 2:03 p.m. This included discussion on cash table's positive outcome, the operating budget, how the Foundation relates, how student enrollment factors in, and the status of expenses.
