## **Fall 2023 Admissions Report**New Undergraduates First-Time and Transfer



This report summarizes Fall 2023 new student enrollment of First-Time First-Year (FTF) and Transfer (TRN) students. As classified by the state of Colorado, first-year students are any student who has not enrolled in any postsecondary coursework after the completion of their time in high school whereas a transfer student refers to any student entering University of Northern Colorado (UNC) for the first time known to have previously attended a postsecondary institution at the same level (e.g. undergraduate) after high school graduation (or passing an equivalency exam). The student may transfer with or without credit.

#### **Overview**

The total number of new incoming undergraduate students increased as compared to the previous year for the first-time since 2016 (see Figure 4). This overall increase of 2.9% in new student enrollment (Table 1) can be attributed to an increase in CO resident first-time, first-year students (Table 3). The number of new transfer students matched last year's enrollment of 535 students with a notable 9.7% increase in traditional, full-time enrollment of transfer students (Table 1). Amongst new transfer students, the number of non-resident citizen, non-resident non-citizen, and WUE transfer students each increased. For the second consecutive year the number of transfer applications decreased however the impact on enrollment was minimized with a notable increase in transfer yield percentage (54.1% as compared to 50.9 percent, see table 2). First-time first-year student applications and admits each saw an 11% increase respectively (Table 2) resulting in a 1.0% decline in yield of new first-time, first-year students.

Fall 2023 marked the implementation of UNC's first-of-its-king Colorado First-Year Guaranteed Admissions Program providing a pathway to direct and expedited admission for a majority of resident applicants. 
#### **Destination UNC Admitted Student Events:**

These exclusive on-campus events hosted throughout Spring semester had a significant and positive impact on new student enrollment. Across three events we welcomed 1,190 attendees and 690 students. Of the students who attended an event, 71.9% enrolled. Additionally, 28.8% of no-shows and 42.1% of students who cancelled their registration enrolled making a student who registered for Destination UNC at least twice as likely to enroll as a student who did not.

#### **Academic Profile: First-Time First-Year Students**

NOTE: SAT scores for all years are based on the redesigned SAT exam.

UNC remains test-optional following the national trend that persisted following the COVID-19 pandemic. Test-optional admissions continues to show virtually no impact on average or median ACT and SAT scores of incoming students (Table 5). The Fall 2023 class average GPAs did see a positive trend and increase (Table 5). The percent of first-time students entering with college credit increased 7% from the previous year (Table 6) with a balanced increase in credit from concurrent enrollment and academic exams. The increase in Colorado resident enrollment shows increases across five of the top 10 feeder counties include a 22% increase in students enrolled from Weld County, a 37% increase in El Paso County, a 22% increase in Larimer County, and 16% increase in Denver County (Table 7).

In late 2022 the Office of Admissions reorganized to create a dedicated Diversity & Access team to support recruitment of first-time, first-year primarily resident students.

#### **Academic Profile: Transfer Students**

The cumulative GPA averages for new transfer students saw a slight decreased for the mean, median and middle 50% (Table 8). The top ten feeder institutions for transfer students remained consistent with the exception of Capital Normal University, a partnership university located in Beijing. Enrollment from Aims CC increased 34% over the previous year (Table 9) attributed to increased partnership and collaboration with Aims, and increased enrollment directly from the Aims2UNC program.

The number of Pell-Eligible and First -Generation students increased 2% and 3% respectively to their highest levels since Fall 2019 (Table 10). The number of male identified students declined 5%, consistent with national trends (Table 10).

## **Enrollment Report Overview**

This report summarizes UNC's overall Fall 2023 enrollment data based on official census day numbers for both undergraduate and graduate student populations. These numbers reflect both our new incoming students as well as continuing student populations, providing an overall enrollment snapshot post census.

The University continues to see decreases in total number of enrolled students for both our undergraduate and graduate populations. Although we continue to see decreases in overall enrollment across the University, there has been significant progress made to various key enrollment indicators across multiple student populations, including intentional efforts being done in support the University's pursuit of becoming a Hispanic Serving Institution (HSI).

## **Undergraduate Enrollment**

Our Fall of 2022 overall undergraduate enrollment saw a decrease of 9.9% for all Degree-Seeking Undergraduate (UG) students. For Fall 2023, that decrease was reduced to 5.4% (Table 1) due to increases to new, incoming UG student populations and our 2nd highest Fall to Fall retention rate for New, First-Time students of 74.5% on record (Table 14). Additionally, UNC's overall retention rates for all degree-seeking UG students increased to 84.5%, the highest overall retention rate since 2009 (Table 15).

New First-Time, degree-seeking UG students saw a 2.9% increase for Fall 2023. This is the first increase for New, First-Time degree -seeking students since 2016 (Table 1). UNC also increased the yield (conversion of Admits to Enrolled students) on New, Transfer UG students by 3% year over year, sustaining enrollment with Fall 2022 New Transfer numbers (Table 1 and 3). The 535 New Transfer students exceeded the projected Fall 2023 budgeted number by 7%, or a total of 35 students (Table 1). This increase was due in large part to the AIMS2UNC partnership. Fall 2023 saw 64 New Transfer, degree-seeking students enroll at UNC through the AIMS2UNC program,. This is an increase of 35 students from Fall 2022.

The University also saw enrollment increases across key markets within the state of Colorado. Weld, Larimer, and El Paso County saw increases for New First-Time enrollment compared to Fall 2022. Weld and Larimer counties saw a 22% increase and El Paso County had a 37% increase. Growth in these counties was intentional with recruitment and enrollment efforts implemented as a part of updated territory management initiatives by our undergraduate admissions team (Fall 2023 Admissions Report, Table 7).

As the work continues towards becoming a Hispanic Serving Institution, the percentage of UNC's Hispanic/Latinx undergraduate population is 26.3%, the highest percentage over the past 5 years and up .8% from point-in-time last year (Table 2). This is a significant milestone towards UNC's HSI federal designation (Table 19).

#### **Graduate Enrollment**

Overall Graduate enrollment will see a decrease mainly due to the graduation of larger classes during the last academic year. New, First-Time, degree-seeking students are only slightly behind Fall 2022 (Table 1), with Enrolled Admits increasing slightly across all campus locations from 815 in Fall 2022 to 821 for Fall 2023 (Table 8). Continuing, degree-seeking Graduate students surpassed budget projections by nearly 100 students, or 7% (Table 1).

Fall 2023 Graduate enrollment was a campus-wide effort, with multiple units and teams filling in and supporting graduate students continuation towards their degree, or enrollment as new, first-time students. Intentional efforts were launched in collaboration with the Graduate School and Admissions to ensure that students were able to navigate the enrollment processes. Moving forward, additional resources and positions will be dedicated to Graduate admissions and enrollment.



Our three-year enrollment trends continue to see decreases in overall Undergraduate (UG) enrollment but also saw increases to New, First-Time students for the first time since 2016. New, First-Time, full-time transfer students increased by 38 students year over year. Overall, Total Degree-Seeking UG Headcount will be down 5.4%, a4.5% reduction in our decrease compared to Fall 2022.

Table 2 identifies overall UG and GR enrollment numbers by college. Although most colleges have seen decreases to their overall UG enrollment, many have significantly minimized the rate in which those decreases where happening, with Performing and Visual Arts seeing an increase year over year. Table 3 breaks down residency status for New, First-Time, New Transfer and Continuing/Re-Admit. Overall resident populations remained the same compared to Fall 2022 at 80%.

As mentioned in the overview, The Fall 2022 New, First-Time cohort had 2nd highest 1st Fall to 2nd Fall retention rates on record at 74.5% (Table 14). Overall persistence of all degree-seeking undergraduates landed at 84.5%, the highest overall persistence rate since 2009 (Table 15). These are significant enrollment indicators and those that directly align with Rowing, Not Drifting as well as the work being done as a part of UNC's Strategic Enrollment Management (SEM) plan.

Fall 2022 URM 1st Fall to 2nd Fall retention for New, First-Time students is significantly below the overall 1st Fall to 2nd Fall retention rate of 74.5%. The persistence rate for all degree-seeking URM students increased for the Fall 2022 cohort by nearly a full percentage point (Table 17).
